Cycles of Violence: Social Mobility as a Predictor of Violent Crime and Homicide *With Kathy Edin and Luke Shaefer*

In this paper, we build on Sharkey and Torrats-Espinosa's (2017) finding that violence depresses community social mobility by providing preliminary evidence that depressed social mobility is associated with later community violence. Our findings provide evidence for a positive feedback loop wherein violence depresses social mobility and social mobility produces further community violence. This feedback loop has the potential to trap communities in cycles of deep disadvantage.

Southern Trees Bear Strange Fruit: The Effects of Slavery and Lynching on Disadvantage Today

With Kathy Edin and Luke Shaefer

Theorists of Black oppression suggest that a series of institutions- slavery, Jim Crow laws, and the criminal justice system- have been implemented successively in America to repress the Black population. We expand on this theoretical work by offering a quantitative analysis of the correlation between slavery and 21st century disadvantage at the county level. Further, we make the case that lynching served as one of these institutions of oppression by examining the correlation between lynching and modern disadvantage. Finally, we assess whether or not these historical institutions primarily laid the groundwork for later institutions (as posited by Alexander 2012) or continue to have a direct effect on Black communities independently.
